AMENDMENT NO. 9 TO THE AGREEMENT FOR CONSULTANT SERVICES BETWEEN THE CITY OF MORRO BAY AND CAROLLO ENGINEER, INC.

This Amendment No. 9 is entered by and among the CITY OF MORRO BAY, a municipal corporation ("City") and CAROLLO ENGINEERS, INC., a Delaware Corporation ("Consultant"). City and Consultant are sometimes collectively referred to as the "Parties."

RECITALS

WHEREAS, City and Consultant entered into an agreement as of April 10, 2018, for consulting services related to the Program Management for the Water Resources Center (WRC Project), which was approved by the City Council for a total not-to-exceed amount of \$292,000 (the "Agreement"); and

WHEREAS, the Parties understood the Agreement was to cover completion of the Project Confirmation phase of the WRF Project (Phase 1); and

WHEREAS, the Parties amended the Agreement on November 27, 2018, to include additional services for a portion of the Project Implementation phase of the WRC Project (Phase 2) and established a total not-to-exceed amount of \$1,898,948.00 for the Agreement; and

WHEREAS, the Parties amended the Agreement on November 7, 2019, to include additional services for a portion of the Project Implementation and Project Oversight phases of the WRC Project (Phase 2 and 3) and established a total not-to-exceed amount of \$4,280,916 for the Agreement; and

WHEREAS, the Parties amended Agreement on June 23, 2020, to include additional services for Project Oversight phases of the WRC Project (Phase 3) and established a total not-to-exceed of \$6,354,049 for the Agreement; and

WHEREAS, the Parties amended Agreement on June 22, 2021, to include additional services for Project Oversight phases of the WRC Project (Phase 3) and established a total not-to-exceed of \$11,808,401 for the Agreement, and

WHEREAS, the Parties amended Agreement as of July 1, 2021, to expand the entities protected by the hold harmless clause in the Agreement; and

WHEREAS, the Parties amended Agreement as of June 14, 2022, to extend the contract expiration date to June 30, 2023 in the Agreement; and

WHEREAS, the Parties amended Agreement as of August 23, 2022, to include additional services for Project Oversight phases of the WRC Project (phase 3) established a total not-to-exceed of \$13,508,401 for the agreement; and

WHEREAS, the Parties amended Agreement as of May 24, 2023, to extend the contract expiration date to June 30, 2024 in the Agreement; and

WHEREAS, the Agreement and the November 27, 2018, November 7, 2019, June 23, 2020, June 22, 2021, July 1, 2021, June 14, 2022, August 23, 2022, and May 24, 2023 amendments are hereinafter referred to as the "Amended Agreement;" and

WHEREAS, due to the completion of both the WRC and the Lift Stations and Offsite Pipelines projects the scope of services and fee schedule shall be amended as outlined in the attached Exhibit A at no cost to the City and the expiration of the Amended Agreement must be extended, as well.

NOW, THEREFORE, City and Consultant mutually agree to further amend the Amended Agreement as follows:

- 1. The expiration date of the Amended Agreement shall be extended to December 31, 2026.
- 2. The effective date of this Amendment No. 9 shall be deemed to be June 11, 2024.
- 3. Consultant's expanded scope of services and fee schedule, as outlined in Exhibit A attached hereto, shall take effect as upon the effective date of this Amendment No. 9 (the "Additional Work"). The Additional Work attached hereto in Exhibit A is additive to, and not a replacement of, work stated in the Amended Agreement.
- 4. Except as expressly stated herein, all terms and conditions in the Amended Agreement shall remain in full force and effect.

A total of approximately 648 hours is allocated to task 9. Individual hour allocations for each subtasks is described below.



Subtask 9.3 - Title XVI

This subtask includes supporting the City and its Program Manager, Confluence, on the Title XVI WIIN grant with USBR. Carollo will provide support in the development of the Title XVI agreement with USBR by participating in discussions related with past construction of the WRF and Conveyance Facilities and prior program management services. This scope does not include contract negotiations or contract review of the forthcoming Title XVI agreement between the City and USBR.

Title XVI reimbursement requests including preparation or transmittal of the reimbursement documentation packages is not included in this subtask. Carollo will provide invoices related with the design and construction of the WRF and Conveyance Facilities. Carollo will serve as a resource to City staff and Program Manager on questions related with the WRF and Conveyance Facilities invoices. This effort is estimated to require approximately 287 hours to complete.

This subtask does not include a second USBR Title XVI or similar new funding application.

Subtask 9.4 - WIFIA

The City has been managing the reimbursement request packages for the WIFIA low-interest loan and anticipates continuing to do so for the remainder of the Project. With this subtask, Carollo will continue supporting the WIFIA loan activities through Q2 FY24/25 (December 31, 2024) by participating in discussions related with past construction of the WRF and Conveyance Facilities and prior program management services. This scope does not include leading any contract negotiations between the City and U.S. EPA.

This subtask does not include any deliverables and provides an allowance of 4 hours per month over 6 months in coordination, meetings, and discussions with the Program Manager for two Carollo staff members, resulting in a total of 104 hours allotted.

Subtask 9.5 - SRF

This subtask includes supporting the City and its Program Manager, Confluence, on the executed SRF low interest construction loan and planning loan and their associated amendments which are pending execution (anticipated by Summer 2024). Carollo will provide support by participating in discussions related with the execution of the SRF amendments between SWRFB and the City. Carollo will also assist the Program Manager with mapping out the construction loan amendment's Final Budget Approval categories with project scope activities to maximize reimbursement potential. This effort is estimated to require approximately 114 hours to complete.

Carollo has assembled and transmitted all of the reimbursement request packages on behalf of the City to-date, with the last reimbursement requested in July 2023. After amendment execution, Carollo anticipates that up to four reimbursement request packages will need to be assembled and submitted for the WRF and Conveyance construction expenses that are currently being held while the SRF construction loan amendment is pending. This effort is estimated to require approximately 40 hours to complete.



After completion of the reimbursement request packages for the WRF and Conveyance construction expenses, future reimbursement request packages related with Recycled Water Facilities design and construction are anticipated to be completed by the City. Carollo will train City staff and perform review services during the task transition period. Carollo will no longer provide staff augmentation services for facilitating the disbursement package assembly, coordination, and submittals for the WRF Program upon completion of training. Carollo will continue to support this role until end of Q2 FY24/25 – December 31, 2024. A total of 10 hours per month will be allotted, resulting in a total of 60 hours allotted for training.

This scope shall also include the development of a Quality Assurance and Quality Control Plan (QAPP) for the Recycled Water Facilities project. Furthermore, work shall also include the supporting post construction commissioning permitting support for the project which shall include tracer study reporting and permitting document and the commissioning start up records. Approximately 1,026 hours have been allotted to Task 10 for Amendment No. 9.

Assumptions for Amendment No. 9

At this time the project identified includes the permitting of the indirect potable reuse components of the project as understood in the Amendment No. 7 scope of work. Project shall connect to the recycled water facilities pipeline constructed in the Conveyance Facilities project and use recycled water produced at the WRF to injection into the Morro groundwater basin for consumption via IPR. Furthermore the non-potable reuse components include the potential to provide recycled water for landscape irrigation to the Morro Bay Golf Course and Morro Bay High school.
